Please, if you are having a party, ask your guests to be considerate of your neighbors when they park their car. We ask that you first utilize your driveway for guest parking before allowing parking on the street. If it becomes necessary for any guest to park on the street, make sure they don't park on your neighbors grass or sprinklers or block their driveway or any roadways, e.g., cul-de-sac turnarounds. Thank you for your kind consideration of your neighbors and others who visit our community.

Many residents are not using trash containers when they put their garage out on pick up day. The birds are having a field day tearing into the bags, therefore making a mess all over the

street. Per the deed Restrictions, "*All trash, garbage and other waste shall be kept in sanitary containers and, except during pick-up, if required to be placed at the curb, all containers shall be kept out of view from the road.*" Using a container will also save you from the extra work of cleaning up the mess the birds make. So please use a trash container.

A number of homes are not complying with the covenant that regulates boats and motor vehicles. The covenants state that you must park at least two vehicles in your garage overnight. Your garage must not be filled with other items that would prevent the parking of two vehicles.

With so many families owning more than two vehicles, it is very important to adhere to the

requirement of parking at least two vehicles in the garage. If we look at other communities that do not have this rule, it becomes very obvious why this requirement helps to maintain our property values.

Florida's 4th of July Fireworks Regulations

When it comes to the 4th of July and fireworks, the rules are pretty much based on common sense:

- do not hold in hand
- light fuse and get away
- **do not disturb the neighbors**
- no fireworks near the airport

For Floridians, though, there is one more fireworks rule which may not be so intuitive. Florida is one of about 20 states that allow consumer fireworks within regulations. Maybe your pack of Black Cat firecrackers or jumping jacks is perfectly innocuous, but how about bottle

rockets and mortars?

To help Floridians abide by the law this 4th of July, the state fire marshal has published an online, searchable list of legally allowed consumer fireworks. This list is freely available to the public online at <http://www.fldfs.com/sfm/pdf/Sparklers2009.pdf>

Even though it is a bureaucratic publication, the list is quite easy to use. Say, for example, you want to purchase a Peacock brand "Baby Fountain" (a 4" cylinder designed to shoot sparks into

the sky). Simply load up the list, click "Search," type "Baby Fountain" and press enter. Voila, right there on page three is your firework.

A second search on "Dixie Canon," a mortar device that sends nearly professional-grade explosives high into the sky much like municipal Independence Day displays, yields no results. According to the state fire marshal, the Dixie Canon contains too much black powder to be acceptable for consumer use, thus it is illegal.

Of course, this list only

defines the specific products allowed by the state of Florida. Residents of Florida must also abide by local county and, if applicable, city regulations. Fireworks regulations vary by county and even by city.

The underlying factor in all fireworks regulations is safety. With some common sense and adherence to the word of the law, Floridians can celebrate Independence Day legally and safely while still having a great time.

Living with Wildlife

Florida Fish and Wildlife Conservation Commission

Florida's wildlife and human population are encountering each other more often than ever before. As humans develop more open space and wildlife habitat is reduced and fragmented, encounters between humans and wildlife become more common. For most people, observing wildlife is a thrilling experience, but when an animal causes damage or attempts to share your living space, that thrill can turn to irritation or fear.

Just like us, birds and other animals are doing their best to make a living and raise their young. Developing an appreciation and understanding of your wild neighbors can help you learn to accept them and live in harmony with them without resorting to extreme measures. Tips for keeping

the awe in your wildlife experience.

- Feeding wildlife accustoms them to humans and is a certain death sentence for bears, alligators and other species.
- Making simple accommodations will often solve the problem of marauding raccoons and other critters. Remove the free meal attractant by feeding pets indoors, installing baffles on bird feeder poles and fastening trash cans lids with rubber straps.
- Additional modifications, like constructing a bear-resistant garbage can caddy and securing compost piles, gardens and beehives behind bear-resistant electric fencing, will discourage

black bears.

- Bringing pets inside at night will keep them safe from hungry predators.
- Cover possible entryways with hardware cloth to exclude squirrels, bats and other animals scouting out your home for a safe place to raise young.

Although relocation is sometimes necessary, trapping and relocating wildlife is a last resort and only warranted if all other measures have failed and an animal becomes a threat. Removing one animal may only serve to open up territory for others to move in. Rather than getting your feathers ruffled, make simple accommodations to avoid wildlife conflicts then relax and enjoy the wonders of wildlife in your own backyard.

Even though it is a bureaucratic publication, the list is quite easy to use. Say, for example, you want to purchase a Peacock brand "Baby Fountain" (a 4" cylinder designed to shoot sparks into

the sky). Simply load up the list, click "Search," type "Baby Fountain" and press enter. Voila, right there on page three is your firework.

A second search on "Dixie Canon," a mortar device that sends nearly professional-grade explosives high into the sky much like municipal Independence Day displays, yields no results. According to the state fire marshal, the Dixie Canon contains too much black powder to be acceptable for consumer use, thus it is illegal.

Of course, this list only

defines the specific products allowed by the state of Florida. Residents of Florida must also abide by local county and, if applicable, city regulations. Fireworks regulations vary by county and even by city.

The underlying factor in all fireworks regulations is safety. With some common sense and adherence to the word of the law, Floridians can celebrate Independence Day legally and safely while still having a great time.

Living with Wildlife

Florida Fish and Wildlife Conservation Commission

Florida's wildlife and human population are encountering each other more often than ever before. As humans develop more open space and wildlife habitat is reduced and fragmented, encounters between humans and wildlife become more common. For most people, observing wildlife is a thrilling experience, but when an animal causes damage or attempts to share your living space, that thrill can turn to irritation or fear.

Just like us, birds and other animals are doing their best to make a living and raise their young. Developing an appreciation and understanding of your wild neighbors can help you learn to accept them and live in harmony with them without resorting to extreme measures. Tips for keeping

the awe in your wildlife experience.

- Feeding wildlife accustoms them to humans and is a certain death sentence for bears, alligators and other species.
- Making simple accommodations will often solve the problem of marauding raccoons and other critters. Remove the free meal attractant by feeding pets indoors, installing baffles on bird feeder poles and fastening trash cans lids with rubber straps.
- Additional modifications, like constructing a bear-resistant garbage can caddy and securing compost piles, gardens and beehives behind bear-resistant electric fencing, will discourage

black bears.

- Bringing pets inside at night will keep them safe from hungry predators.
- Cover possible entryways with hardware cloth to exclude squirrels, bats and other animals scouting out your home for a safe place to raise young.

Although relocation is sometimes necessary, trapping and relocating wildlife is a last resort and only warranted if all other measures have failed and an animal becomes a threat. Removing one animal may only serve to open up territory for others to move in. Rather than getting your feathers ruffled, make simple accommodations to avoid wildlife conflicts then relax and enjoy the wonders of wildlife in your own backyard.
